ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Let a confeacher Education Act. 1993 (73 of 1993) and in supersession of the National Council for 1 Laucation (Recognition Norms and Procedure) Regulations, 2009, the National Council for eact. duration has notified the Regulations, 2014 on 01.12.2014.

AND WHEREAS, the included i.e. Sha R.K. B.Ed. College, Justin, Jounjhung Road, Malsasar, District - Jhunjhunu, Rajasthan has been recognized for B.f.a. to NRC vide order No. 1 NRC NCTE/1-7/ RJ-1565/2008/64107 dt. 29.09.2008 for an intake of 100.

AND WHEREAS, the institution Shri R.K. B.Ed. College, Busau, Jhunjhanu Road, Malsisar, District - Junifunu, Rajasthan has by affidavit consented to come under New Regulations and sought for two basic units to B. Ed., which require additional facilities.

AND WHEREAS, it has been decided to permit the institution two basic units of 50 students each ar jeet to fulfillment of the following conditions namely.

- .) The institution shall create additional facilities which include (a) additional built-up-area, (b) additional intenstructure, (c) additional funds, (d) adherence to staff norms as per Regulations, 244 and inform the Regional Committees with required documents by October 31, 2015. The applicant incurrious for additional unit will be required to submit the required documents.
 - such as land documents, Non-Lucumbrance Certificate (NFC). Land Use Certificate (CLU) and the Building Plan (BP) in the format available on the website, to the Regional Committee in proof of having provided additional facilities, before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents, if available, otherwise it may be given to the sur as Team at the time of inspection.
 - the pregional Committee shall arrange for verification of documents, inspection of the premises heck adherence to these conditions by 20 February, 2016. If it is found by the Regional committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTF Act! Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. Ta case the institution's request for shifting of premises is pending. such institution shall be required to submit the requisite documents as per provisions of the NCTF Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order Shri R.K. B.Ed. College, Busau, Jhunjhunu Road, Malsisar, District -Jhunjhunu, Rajasthan for conducting B.Ed. programme of two years duration with an annual intake of Total for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein, before 31.10.2015.

State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & nonteaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
 - Sanctioned programmes along with annual intake in the institution. (a)
 - Name of the faculty and staff in full as mentioned in school certificate along with their (6) qualifications, scale of pay and photograph.
 - Name of faculty members who left or joined during the last quarter. (c)
 - Names of students admitted during the current session along with qualification. Percentage of (d) marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - (c) Fee charged from students.
 - Available infrastructural facilities. (1)
 - Facilities added during the last quarter. (2)
 - Number of books in the library, journals subscribed to and additions, if any, in the last quarter. (h)
 - The affidavit with enclosure submitted along with application. (i)
 - The institution shall be free to post additional relevant information, if is so desires, (i)
 - Any false or incomplete information on website shall render the institution liable for withdrawal of (k) recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act. Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section
